2003 - 2005	<p>With the active support of WaterAid, UK and Water.org, a Centre for Toilet Technology and Training was established at the Gramalaya Training centre which was replicated all over in Tamil Nadu and in other States in India. He has developed more than 24 low-cost toilet models right from zero budget cost toilets and upto eco-san toilet models.</p> <p>The idea of CLTS –Community Led Total Sanitation was field tested and replicated in the rural areas with funding support of Water.org where the communities were provided with water and sanitation facilities. A revolving fund was introduced in the rural areas for providing loans to women self-help groups for installation of water connections and toilets at the household-level. The concept was successfully field tested by Water.org in the project areas of Gramalaya and later on expanded as WaterCredit Initiatives. With the funding support of Water.org, a resource centre was established as National Institute for Water and Sanitation – NIWAS for providing capacity building training to interested organizations and government officials. He was instrumental in forming a separate entity for providing water and sanitation loans through Guardian MFI, a section 25 company registered as a not-for-profit entity.</p>

1995 - 2002	<p>While working as the Executive Director of Gramalaya, involved in designing urban interventions and school health programs in the rural areas with WaterAid, UK funding. The project at the beginning started with drinking water supply through handpumps installation, school health programs with child-to-child approach, construction of low-cost toilets and community managed pay-and-use toilets in the urban slums of Tiruchirappalli City corporation. He was instrumental in announcing the India's first village and first slum stopped open defecation practices and thereby announced as Open defecation free zones in Tiruchirappalli District.</p> <p>He has developed a number of hygiene education materials as a part of IEC – Information, Education and Communication development. He was instrumental in designing and developing, publishing of resource materials and hygiene educational materials such as pamphlets, posters, flash cards, booklets and training manuals for community health workers, handpump maintenance and caretakers manual, slides and video films for WaterAid, UK.</p>

As a manager of the project, the project field team was worked under his guidance in planning, implementation, monitoring and reporting of activities to APAC-USAID unit which was functioning under the bilateral agreement with Government of India and National AIDS Control Organization. During the project period, he has developed a number of flip charts, snake and ladder game and other survey materials.</p>
